

Mustang Club of Central PA Minutes

October 17, 2013

The meeting was called to order at 6:30 PM, October 17, 2013 at LB Smith Ford, Lemoyne, PA by President Bob Ardner, followed by the pledge of allegiance. The membership (16 present) then began introductions.

President Ardner stated the minutes from the September 19th meeting had been posted on the website. A motion was moved by Charlie Boyd, and then seconded by Dennis Reddinger, to accept the minutes as posted.

President Ardner also instructed the membership to review the new bylaws that are now posted on the website.

The treasurer's report was distributed and presented by Charlie Boyd. The current balance was \$4042.52 as of October 15, 2013. A motion was moved by Dale Warner, and then seconded by Kevin Buecher, to accept the report as read.

President Ardner reported that Mike Cole could not attend the meeting, but wanted the club to be aware that the Covered Bridge Cruise is scheduled for Sunday, October 27, 2013. Mike also wanted us to know that Darlene from Bill Collins garage, where we are touring prior to the final club meeting at Duke's on November 9th, was going to try to stop by the meeting tonight.

Charlie Boyd reported the current membership total is 82 members.

President Ardner reported that he received word from the MCA about having a branch of MCCPA in Lancaster. An email he received from Jim Keenan, MCA National Secretary, stated that there were no conflicts with us branching out to Lancaster area. Charlie Boyd suggested we could have the Lancaster members organize their own meetings, and maybe we can have one or two members who can attend our meeting in Lemoyne as well as the Lancaster meetings. The Lancaster members would be considered a satellite group of our club, but are not required to attend the meetings in Harrisburg. Joe Cressler suggested that if they have a large number of interested members, maybe it would be better for them to start their own club. Kathy Klunk suggested that Lancaster residents are more than welcome to become members. They don't necessarily need to be involved with meetings. President Ardner stated he will compile the information, and pass it along to Mike.

President Ardner reported that the Round Up Winners and the bylaws have been posted on the website. The minutes as well as the current Facebook link have been updated on the website. Bob Ardner III is
